1. Background

The Smallholder Agricultural Competitiveness Project (SACP) is financed by International Fund for Agricultural Development (IFAD) which has been engaged in agriculture and rural development for 40 years in Bangladesh, aiming to provide an opportunity for further scaling-up and enhancing some of the best practices and innovations that have proven to be useful climate change adaptation responses, as well as introducing practical methods and technologies in sustainable production enhancement, post-harvest management, value chain development and public-private partnership development. Through a direct partnership with the Ministry of Agriculture, SACP is supporting the Government's strategic master plan of transforming agriculture in Southern Bangladesh.

The SACP project is implemented in 20 districts covering 90 Upazilas in the Southern and Norther Regions (Coastal Zone, Barind and Drought Prone Areas and River Systems and Estuaries-char) areas of Bangladesh, covering 750 unions selected based on the targeting criteria. The project is implemented by five agencies (DAE, DAM, BADC, BARI and FAO).

Overall objective of SACP

The overall objective of the project is to increase farmer incomes and livelihood resilience through demand-led productivity growth, diversification and marketing in a changing climatic condition; To contribute to the public investment priority of achieving food security, and to promote sustainable, inclusive, climate-resilient, and nutrition-sensitive agriculture in three major climatic hotspots of Bangladesh.

Project Structure

The project is implemented by four departments of MoA through three technical components supported by a project management component. Component 1-Enhanced production of High Value Crops (HVCs) and technology adoption, is led by the Department of Agricultural Extension (DAE) with support from Bangladesh Agricultural Research Institute (BARI). Component 2- Processing and Marketing of HVCs is led by the Department of Agricultural Marketing (DAM), and Component 3-Climate Resilient Surface Water Management is led by the Bangladesh Agriculture Development Corporation (BADC). These four departments together form the project management component supported by technical assistance from the Food and Agriculture Organization of the United Nations (FAO). An additional Component, Diversified Resilient Agriculture for Food and Nutrition Security (RAINS) will be implemented from 2023.

2. Objective of the Assignment

The overall objectives of this assignment are to assist the project management of SACP in the Monitoring and Evaluation (M&E) and Knowledge Management (KM) to enable co-ordination for successful implementation of the project activities in achieving the objectives as stipulated in the project document.

3. Scope of Services / Duties and Responsibilities:

General Responsibilities: The M&E-KM Specialist (Consultant) (Full time) will work as a part of the Project Management Unit to lead the implementation of project's monitoring, evaluation and knowledge management activities under the supervision of the Project Director. The scope of services/ duties and responsibilities of the consultant are the following:

- 3. Develop and update frameworks, guidelines and tools related to planning, monitoring, results measurement, evaluation, information and knowledge management as per Donor's and Government's of Bangladesh requirements.

- b. Implement and revise Environmental and Social Management Plan (ESMP) in line with IFAD's Social, Environmental and Climate Assessment Procedures (SECAP)
- c. Ensure systematic data collection reflecting project's implementation progress and achieved outputs and impact.
- d. Ensure monitoring and evaluation of project activities to be performed by the field offices are attended and delivered in a correct and timely manner as per results framework
- e. Carry out annual outcome survey, impact study in line with IFAD's Core Outcome Indicator guidelines
- f. Ensure compliance with the GAFSP reporting requirements as part of the RAINS subcomponent

- Prior experience in working as M&E specialist in development projects is desirable.
