Terms of Reference (ToR)

for Baseline Survey under Diversified Resilient Agriculture for Improved Food and Nutrition Security (RAINS) of the Smallholder Agricultural Competitiveness Project (SACP-RAINS)

Background:

Bangladesh is a lower middle-income country with medium but declining rates of poverty among its 160 million people. Sustained economic growth along with steady agricultural improvement has been fundamental to this reduction. Sustainability of growth, particularly agricultural growth is, however, particularly vulnerable to climate change. Given that the agriculture sector remains fundamentally important to the country's prosperity and it utilizes three-quarters of the land space of Bangladesh and supports the livelihoods of the majority of the population, it is passing through some immediate challenges in promoting sustainable development. The challenges include continuing to increase production and achieve recognizable quality standards despite loss of land to other uses and climate change.

The proportion of the population living under \$1.25 a day fell from 49 percent to 24.8 percent between 2000 and 2015, effectively lifting millions of people out of poverty during the period. Overall poverty has declined during the last decade. However, poverty in rural areas remains around 36 percent and has not declined as fast as in urban areas. Additionally, the proportion of people living in extreme poverty in rural areas is still three times higher than in urban areas.

Women are particularly affected by poverty, as they have fewer opportunities for employment than men and bear the responsibility of caring for their families. With a 'demographic dividend' of young adults entering the labour market in the country, rural youth may be more attracted by labour or employment migration to the urban areas, as they are among those who find difficult to be involved in agriculture due to the lack of assets and skills. In general, the youth are motivated and dynamic; inclusive and tailor-made measures can turn them into viable socio-economic actors. Thus, this project will emphasize the high value crops that will provide enough income to keep such motivated and dynamic youth and women involved in agriculture.

Rural poverty is closely linked to food security. For the average rural household, about 71 percent of calories come from rice. In the last 20 years, consumption of cereals (including rice) decreased, in absolute and relative terms, and average per capita consumption of all other food groups increased, indicating improved dietary diversity. However, progress in diet diversification was slower in rural areas compared to urban areas. Thus, this project can address the growing desire of Bangladeshis for improved diets through higher and oftentimes, more nutritious high value crops.

With the funds from GAFSP (Global Agriculture and Food Security Program) through International Fund for Agricultural Development (IFAD) and with the technical assistance of the Food & Agriculture Organization of the United Nations, the government of Bangladesh has developed the SACP-RAINS (Diversified Resilient Agriculture for Improved Food and Nutrition Security) Project to increase farmer incomes and livelihood resilience through demand-led productivity growth, diversification and marketing under changing climatic conditions. The project builds on the assumption that with the opening of the Padma and Bangabandhu multipurpose bridge, many farmers of the southern and northern districts will have increased opportunities to sell their products to Dhaka markets (high value crops, vegetables, legumes and fruits), the shortened transit times will

expand the opportunities for high value fresh produce that is properly picked, packed and transported and where the project can play a significant role in improving current practices. The focus will be to enhance production quantity and quality through appropriate productive infrastructures, quality agriculture inputs and training of farmers and value chain actors, as well as, linking farmers and their groups to private dealers and traders to enhance fair contract farming and postharvest and processing contracts.

The project goal is to contribute to Bangladesh's agriculture smallholders' responsiveness and competitiveness in high value crop (HVC) production and marketing of fresh and/or processed products. The project objective is to increase farmer income and livelihood through demand-led productivity growth, diversification, and marketing in a changing climatic condition. The Project Technical Assistance by FAO will be implemented over a period of 3 years and will enhance the capacity of targeted farmers to address their barriers to entry into the market system and facilitate the development of a more inclusive market system. However, the full implementing project was stated to go over 3-years period.



Objectives of the assignment:

The overall objective of this assignment is to carry out a baseline survey in the project area (14 Districts and 60 Upazilas) to assess the present scenario related to food security, livelihoods, resilience to negative economic shocks, challenges related to agricultural system, existing best practices, nutrition, and women participation in agricultural as well as other income generating activities etc. The sampling of the baseline survey will identify control as well as treatment households so that the impact evaluation can be conducted later through collection of endline data. Please note that these ToRs are focused only on the collection of baseline data and report.

Specific objectives:

- i. To develop a sampling framework for the baseline data collection.
- ii. To assess the present situation of crop production, crop diversity, crop productivity, amount and the quality of inputs used, cropping intensity & scope of increasing diversified crops' production through introducing high value, marketable crops and processing system of HVCs by farmers and other management practices.
- iii. To estimate supply of High Value Crops and size of the local (Upazila) and the regional (district) market demand.

- iv. To map existing post-harvest and market facilities along the value chains of selected HVCs.
- v. To prepare gender disaggregated socio-economic profile of the target farmers (landless, marginal, and small) including the households' existing employment patterns, income levels, productive assets, financial status, food security, food consumption pattern, Income Generating Activity (IGA), knowledge on nutrition, marketing and storage systems of farm produce.
- vi. To determine the knowledge and skills of targeted farmers, including women and youth, in technology transfer and adoption of HVCs.
- vii. To assess the status of horticultural crop/ high value crops' production in the project area, region wise use of agricultural equipment/machineries and identify the possibilities of new agricultural technology.
- viii. To assess access to Internet and level of digital literacy among the targeted farmers, including youth and women.
- ix. To develop an impact evaluation strategy such that the impact of different components of the RAINS project can be quantified later.

Key requirements of the assessment as per project log frame:

The baseline survey will rigorously capture the followings indicators:

- Prevalence of Food Insecurity Experience Scale (FIES) of the targeted population,
- Percentage of Household Dietary Diversity Score (HDDS) of the targeted population,
- Percentage of Minimum Dietary Diversity for Women (MDDW) of the targeted population,
- Annual income of the targeted population from diversified and climate smart production and marketing,
- Household-level crop and income diversification index,
- Percentage of targeted population having new/improved inputs, technologies, or practices in agriculture,
- Annual Households production in the targeted area (crop wise),
- Percentage of targeted population adopting environmentally sustainable and climate resilient technologies and practices in agriculture and their livelihoods,
- Percentage of targeted population using different sources of water for irrigation,
- Percentage of targeted population are embedded with any groups or organizations (disaggregated by group/organization),
- Percentage of targeted rural producers accessing production inputs and/or technological packages (productivity enhancement and climate smart agriculture),
- Percentage of targeted population are trained in production practices and/or technologies (productivity enhancement and climate smart agriculture) support in the targeted population,
- Number of technologies including *climate smart on-farm water management* for irrigation are being used by targeted population,
- Percentage of targeted population are using different irrigation technologies (technology wise population Percentage),

- Number of hectares of Farmland are being used by targeted population under technologies including climate smart on farm water management for irrigation.
- Farmers annual sale per hectare (crop-wise),
- Percentage of targeted population having access to collection (aggregation), processing and storage facilities.
- Percentage of targeted population having access to marketing information and extension services.
- Percentage of targeted population having access to finance, with disaggregation per type of institution (i.e., commercial banks, Krishi banks, microcredit institutions, saving groups, NGOs, etc.)
- Percentage of persons with improved nutrition Knowledge Attitudes and Practices (KAP).

Methodological and Practical Considerations:

The main aim of the baseline data collection is to assess the impacts of different components of SACP-RAINS project on household food security, dietary diversity, resilience, diversification and other gender-related outcomes. Therefore, there is a need to develop a robust impact evaluation strategy to quantify the impacts of different components (as outlined in the project log-frame) of SACP-RAINS.

The Consultant is expected to employ various participatory methodologies that are holistic rather than sectoral to provide lessons to the implementers. Different tools can be used in the evaluation (e.g., group discussions or FGD, key informant interview (KII), structured questionnaires, surveys, interviews, observations, workshops, meetings, review of the documents, etc.) are expected in an elaborated manner. In addition, the evaluation team should be gender-balanced, and gender-sensitive teams and data should be disaggregated by gender. In the Baseline Survey process, the different components and Upazila to be included during the data collection process, so that a comprehensive perspective can be captured in the review process.

Sampling plan: The Consulting Firm will determine the representative sample size following the IFAD guideline and applying prescribed formula. The firm will prepare a detailed sampling plan selecting treatment farmers and control groups from the project working area.

Documents Review: The team of the recruited Consulting Firm will review project documents, Project Design Report (PDR), Development Project Proposal (DPP), IFAD Mission reports, baseline of SACP and all other relevant reports of the previous project to know the project results, impacts, outcome, and outputs achieved since its inception.

Discussion/Consultation: The assessment team will meet Project Officials of different components of SACP-RAINS and other stakeholders of Union/Upazila/District level separately to explore the outputs/results achieved by the project during the period covered and collect evidence of the changes created due to project interventions.

Administered of Questionnaires: The consulting firm will prepare Baseline Survey questionnaire following the guideline of IFAD and align with SACP baseline to collect the quantitative data from sampled household and control group. Since the Mid Term Impact survey will be done based on baseline survey and Final Impact Survey, the consulting firm should consider this issue in designing questionnaire for the Baseline Survey. The consulting firm should finalize the questionnaire after having discussion with concerned officials of SACP-RAINS.

Training of Enumerators: The consulting film will have to provide comprehensive hands-on training on data collection process with making them clear understanding on data collection tools.

Household's interview: The recruited Enumerators by the Consulting Firm will collect data through the interview from households and control group using an administered questionnaire.

Interview: The assessment team will meet the senior management of different components to discuss any policy and strategic issues relating to the ongoing project implementation and future course of actions.

Focus Group Discussion (FGD): The assessment team will conduct Focus Group Discussions with Farmers Group to assess the benefits of the project intervention and explore the areas where the action is further necessary.

Key Informant Interview (KII): The assessment team will conduct with the SCAP-RAINS senior management, Deputy Director-DAE, Upazila Agricultural Officer, DAM, BADC, BARI Officials, GAINS, FAO-TA and Private Sector Entrepreneur and other necessary stakeholders.

Draft report preparation: The Consulting Firm will prepare a draft report comparing with collected data and other information including control group to assess the actual project achievement.

Debriefing Session and Data validation workshop: Before submitting the final report, a debriefing session will be held where the Consultant team will present the key findings and recommendations before the officials from the SACP-RAINS project and selected persons from other stakeholders through conducting a validation workshop. The cost of the validation workshop will bear by the Consulting Firm.

Submission of Final report preparation: The Consulting Firm will prepare the final report after the debriefing session and incorporate feedback from the debriefing and data validation workshop using the standard reporting template.

Accountability and Support:

The Consulting Firm will directly report to the Project Director and closely work in collaboration with Deputy Project Director (DPD), Senior Monitoring Officers and Monitoring and Evaluation-Knowledge Management specialists. In addition, the Component Directors and Deputy Components Directors will provide necessary support (if any) as and when required. In addition, the Sub Assistant Agriculture Officer (SAAO) and Junior Monitoring and Reporting Specialist (JMRS) will provide essential support in the data collection process at the field level.

Duration and Location:

The Baseline Survey will take place from January to March 2024. The whole process, including final report preparation, feedback collection incorporation, and final report submission, should be completed by this three months' period, of which maximum one month should be spent at the field level. The working locations for evaluating 60 Upazilas (sub-district) under 14 Districts.

Confidentiality and copyright

All papers shared with the consultant are confidential to the SACP-RAINS and should not be used outside of SACP-RAINS without permission. Information received by the consultant from the SACP-RAINS and fields and offices should be treated confidentially. The assessment report will be owned by the SACP-RAINS and disseminated as the organization sees fit.

Survey Period:

The survey should be completed, and a Draft Final Report must be submitted within 75 days from the date of contract signing by the firm. The Final Report will have to be submitted within 15 days of the presentation of the Draft Final Report after incorporating clarifications and additional information in response to the comments given by SACP officials.

However, the data collection should be completed within two months of the contract coming into effect.

- **b)** Sexual exploitation and abuse means any actual or attempted abuse of a position of vulnerability, differential power, or trust, for sexual purposes, including, but not limited to, profiting monetarily, socially or politically from the sexual exploitation of others (sexual exploitation); the actual or threatened physical intrusion of a sexual nature, whether by force or under unequal or coercive conditions (sexual abuse).

Purchasers, suppliers and bidders shall take all appropriate measures to prevent and prohibit sexual harassment and sexual exploitation and abuse on the part of their personnel and subcontractors or anyone else directly or indirectly employed by them or any of subcontractors in the performance of the contract. Purchasers, suppliers and bidders shall immediately report to the purchaser or IFAD any incidents of sexual harassment and sexual exploitation and abuse arising out of or in connection with the performance of the contract or prior to its execution, including convictions, disciplinary measures, sanctions or investigations. The purchaser may take appropriate measures, including the termination of the contract, on the basis of proven acts of sexual harassment, sexual exploitation and abuse arising out of or in connection with the performance of the contract.

The bidder or supplier is required to disclose any relevant prior sanctions, convictions, disciplinary measures or criminal records.

- ii. He/ She will have at least 5 years of adequate professional experience in agriculture.
- iii. He/ She will have excellent skills in report writing with adequate knowledge in research methodology for survey works.
- iv. Expertise in selection appropriate, diversified cropping patterns and identification of low water requiring high value crops.
- v. He/ She should be fit to undertake frequent field visits in the remote areas of Bangladesh.
- vi. He/She should have adequate knowledge in field monitoring and staff supervision of survey works.

Statistician (One person)

Qualification:

- i. He/ She will have at least Master's degree in Statistics along with high level skills in data analysis and processing.
- ii. He/ She will have at least 10 years of adequate professional experience.
- iii. He/ She will have skill in report writing with adequate knowledge in research methodology for survey works.
- iv. Expertise in sampling methodology preparation, database management and data analysis.
- v. Excellent knowledge of IT tools for data collection and analysis (i.e. KoboToolbox, ODK, PowerBI, Stata, etc.)

Data Analyst (Two persons)

Qualification:

- i. He/ She will have at least Master's degree in Statistics, Economics or similar discipline.
- ii. Minimum 5 years of professional experience, including at least 2 assignments of similar nature.
- iii. Excellent analytical skills and attention to details; data cleaning experience is compulsory.
- iv. He/She should be able to meet short deadlines.

Supervisor (Total 14 persons, each district 1 person)
